
- 1. Rate should be quoted F.O.R NIT Jalandhar.

- 3. Where the Equipment / Machinery/ Instrument /material I are composed of several sub units/components, the rate should be quoted for each subunit/component separately. NIT Jalandhar reserves the right to increase or decrease the number of sub units/components and number of Equipment / Machinery/ Instrument/material/items according to its requirements.
- 4. 




