- 2. Tenders without Digital Signatures will not be accepted by the electronic tendering system. Director, NIT Jalandhar will not be responsible for any delay in online submission of bids due to any reason whatsoever.
- 3. Bids will be opened online as per time given failing which no tender will be submitted.

- 10. The amendment will be published on Tenderwizard and on Institute website only. In order to afford prospective tenderer(s) reasonable time in which to take the amendment into account in preparing their bid, the institute may, at its discretion extend the deadline for the submission of tender.
- 11. The conditional e-bids shall not be considered and will be out rightly rejected.
- 12. The supplier must intimate whether he is manufacturer /authorized distributor /dealer or exclusive agent. In case of supplier or dealer/agent, the authorization from the manufacturer is required and soft copy of the same must be enclosed with the e-bid, failing which their bids will be rejected.
- 13. The tenderers are required to upload self-attested copies of the relevant documents required as per Terms & Conditions of the tender, failing which their ebids may be rejected and will not be considered.
- 14. Tele fax-email and other incomplete offers are liable to be summarily ignored.
- 15. Rates shall be quoted in Indian Rupees & FOR NIT, Jalandhar and excluding taxes. Sales tax/any other chargeable taxes must be specifically mentioned failing which no tax/duty will be allowed at the subsequent stage. It will be termed as inclusive of all taxes.
- 16. The tenderer should clearly indicate the delivery period and validity period of the offer.

- 22. Only successful bidder has to deposit **the Security money of Rs.50,000/-** in the shape of Demand Draft only in favor of the Director Dr B R Ambedkar NIT, Payable at Jalandhar. The performance security will be retained till the validity of Rate Contract period without interest.
- 23. The Rate of Tonners so quoted in commercial bid will be for one year and award of tonner so placed to the bidder on approved rates shall remain firm throughout the Rate Contract period.
- 24. The supplier cannot be charge rates more than MRP if the rates found more than MRP rates at any stage the excess charged amount will be deducted out of their payment.
- 25. Director, NIT Jalandhar reserves the right to enter into parallel Rate Contract for similar items any time during a period of Rate Contract with one or more parties.
- 26. The Rate Contract can be terminated at any time by giving one month's notice by the institute.
- 27. The stores so supplied will have to be of high quality & grade and in the event, if during use of Tonners & cartridge are found to be of inferior quality/duplicate, the supplier is liable to banned or suspended from doing business with NIT Jalandhar and their Security shall be forfeited or the such loss will be deducted from their security.

JURISDICTION:

The courts at Jalandhar alone will have the jurisdiction to trial any matter, dispute or reference between parties arising out of this tender / contract. It is specifically agreed that no court outside and other than Jalandhar Court shall have jurisdiction in the matter.
