(G) PERFORMANCE SECURITY:

The Service Provider shall be required to furnish a Performance Security @5% of the total value of the contract within 15 days from the date of commencement of the Internet Lease Line (1:1) in the form of Demand Draft by any nationalized bank in favor of Director, Dr B R Ambedkar National Institute of Technology, Jalandhar for contract period of one year.

The institute shall provide a Layer 3 Switch to be configured by the ISP.
- d. Liasioning (if required) with other firm(s) for obtaining point to point connectivity between ISP node and Institute, shall be the responsibility of the Service Provider.
- e. The Service Provider would insure that the local loop provisioning does not violate any regulations as laid by Government of India / TRAI in respect of such links / networks. Service Provider shall be responsible for making all the payments towards the local loop charges / rentals/ WPC charges etc.
- f. The Service Provider will do preventive maintenance once a quarter for upkeep of the systems running. The schedule will have to be adhered to strictly by him.
- g. NIT Jalandhar will not purchase any Hardware and ISP will have to provide all the required hardware on latest technology for installation, commissioning and configuring of hardware and uplink of connectivity in the Data Centre of the Institute and will also be fully responsible for its maintenance.
