The tenders will be opened by the committee duly constituted for the purpose on due date and time in the presence of the bidders, whomsoever may wish to be present.

1. All the bids/enquiries should be addressed to the Director, Dr. B. R. Ambedkar National Institute of Technology, Jalandhar.
2. In case of non-compliance of instructions and all the terms & conditions, the offer will not be considered.
3. Bids without GST number and proof of registration as Recycler/Reprocessors/Dismantlers of E-Waste with Central Pollution Control Board/ State Pollution Control Board will be invalid.
4. Bids received after the due date will not be considered unless the date is extended.
5. No extra payment shall be paid on account of any discrepancy in nomenclature of items.
6. While submitting the tender, if any of the prescribed conditions are not fulfilled or are incomplete in any form, the tender is liable to be rejected. If any Tenderer stipulates any condition of his own, such conditional tender is liable to be rejected.
7. Director, NITJ, reserves the right to reject any tender/bid wholly or partly without assigning any reason.

8. The Condemnation Committee constituted by the Director, NITJ shall have the right to verify the particulars furnished by the bidder independently.
9. The work/service invited is for NITJ and the contractor shall be responsible for any damage (if occurs) during the execution of work.
10. All the tender documents & Financial Bid (Annexure-II) to be submitted as per this tender are to be signed by the bidder.
11. Before submitting the bids, the bidder/ tenderer may inspect the condemnation items well in advance with the prior approval from the Registrar during office hours, in order to avoid late complaints in this regard.
12. Bids received physically through courier/post/delivered personally will only be considered.
13. No doubt/clarification pertaining to this Tender by any Bidder shall be entertained after 21.04.2022 by the Institute.

## GENERAL TERMS & CONDITIONS

1. **Rate must be quoted in one lump sum for all the items as per Annexure-III.**
2. The Agency should be a registered Recycler/Reprocessors/Dismantlers of E-Waste with Central Pollution Control Board/ State Pollution Control Board as applicable.
3. The Agency should have valid GST Registration Certificate.
4. GST will be applicable as per rule.
5. The condemnation process should be carried out under the strict supervision of the Institute Condemnation Committee or any other Official deployed for monitoring the condemnation process.
6. Successful highest bidder will make the payment through electronic mode like RTGS/NEFT etc. in the Institute Account before removal of the items from the Institute.
7. No labour/assistance in any mode will be provided by the Institute to the successful bidder for collection of the items to be disposed from various locations of the Institute.
8. **Minimum Reserve Price (MRP):** The Institute has determined the Minimum Reserve Price (MRP) of the lot of items (**at Annexure-III**) proposed to be disposed off through this tender. In case H 1 bidder has quoted less than the MRP fixed by the Institute, negotiation will be carried out with the H1 Bidder. If the negotiation does not provide the desired result, then the reasonable price will be counter offered to the next highest responsive Bidder(s).

### 9. EARNEST MONEY DEPOSIT:

- 9.1 The bids shall be accompanied by an Earnest Money Deposit of Rs. 63,000/- (Sixty Three thousand only) in the form of Demand Draft of any nationalized bank. The validity of the Demand Draft must be up to 3 (three) months starting from the date of submission of the bids. The Demand Draft shall be in favour of Security- A/c, DR B R Ambedkar NIT, Jalandhar. Demand Draft of Rs. 500/- as tender fee must also accompany in favour of Director, Dr. B R Ambedkar NIT, Jalandhar
- 9.2 If the bidder is exempted for payment of Tender Fee and EMD as NSIC/MSME registered bidders, then bidder is required to submit NSIC/MSME exemption certificate for same. The Certificate must be valid as on last date of submission of bid.
- 9.3 The tender is based on two bid system. The Technical Bid (**as per Annexure-I**) and Financial Bid (**as per Annexure-II**) are required to be sealed in separate envelope and these two envelopes should be put in a Larger Size Envelope and should be sealed and sent to this office by due date.
- 9.4 No request for transfer of any previous deposit of earnest money or security deposit or adjustment against any pending bill held by the Institute in respect of any previous work shall be entertained.
- 9.5 Bidders shall not be permitted to withdraw their offer or modify the terms and conditions thereof. In case the bidder fails to observe and comply with the stipulations made herein or backs out after quoting the rates, the aforesaidbid security shall be forfeited.
- 9.6 The bids without Earnest Money and tender fee shall be summarily rejected.
- 9.7 No claim shall lie against the Institute in respect of erosion in the value or interest on the amount of earnest money deposit or security deposit.
- 9.8 The bid security (earnest money deposit) may be forfeited:
  - 9.8.1 If the bidder withdraws his bid during the period of bid validity specified by the bidder in the bid form; or
  - 9.8.2 In case of successful bidder, if the bidder
    - 9.8.2.1 Fails to execute the order in accordance with the terms of the tender document
    - 9.8.2.2 Fails or refuses to honor his own quoted prices or part thereof.

9.8.2.3 In such case, the bidder is also liable to be debarred from future tendering.

9.9 No interest shall be paid on the earnest money deposit.

## 10. VALIDITY OF BIDS

- Bids shall remain valid and open for acceptance for a period of 120 days from the last date of submission of Bids.

## 11. PREPARATION AND SUBMISSION OF TENDER

- The tender document, along with terms and conditions, has been uploaded on CPP Portal and the Institute website i.e. [www.niti.ac.in](http://www.niti.ac.in) >> Tenders . The bidders can log on to the website and see the tender document.
- Name, complete address (location of the office) of the bidder with telephone No., Fax No. & Email must be mentioned in the bid document.
- The bid must be quoted duly typed on the letter heads of the bidder duly mentioned full address, GST No./ PAN No./ TDS No. / TIN No. and must be in a sealed cover which should be superscribed Bid for \_\_\_\_\_Tender No. \_\_\_\_\_dated:\_\_\_\_\_”.
- Incomplete offer (details missing) will not be considered.
- The Bidder should quote in one lump sum in the Financial Bid (**Annexure-II**) for all the items detailed at **Annexure-III** in Indian Rupees (in figures as well as words). In case of difference of rate in figures and words, rate written in words shall only be considered. If rate is not quoted for all the items, the bid will not be valid and hence the same will be rejected.
- The rates quoted shall be firm and final. The taxes/duties/GST etc. are to be paid extra as per rules.

## 12. BID OPENING PROCEDURE AND EVALUATION AND AWARD OF WORK

- The bids shall be opened by a committee of the officers constituted by the competent authority for the purpose at the time and date as specified in the tender document.
- Letter of authorization shall be submitted by the Bidder’s representative; in case they wish to be present for opening of the bids before opening of the Bids.
- Absence of bidder or their representative shall not impair the legality of the opening procedure.
- After opening of the Bids and verifying the EMD/Tender fee amount, the Bidder will be considered further.
- The Bidders with the highest price (H 1 Bidder) mentioned in the PRICE BID shall be awarded the work order for disposing off all the items as per **Annexure-III**. All the items as per **Annexure-III** would be disposed off on ‘**as is where is basis**’ at the quoted prices to the highest bidder.
- The successful Bidder has to make full balance payment (after adjusting the EMD security already deposited) in the form of account payee RTGS / NEFT of Scheduled Commercial bank in favour of Director, NIT, Jalandhar payable at NIT Campus, Jalandhar within 7 working days after acceptance of the Bid failing which the contract shall be cancelled and the EMD deposited by the Bidder shall stand forfeited and no claim will lie on the Institute.
- The successful Bidder shall have to lift the items within 15 working days of the award of the work order.
- If the successful Bidder (H 1) fails to deposit the quoted amount within the stipulated time,

the next highest Bidder (s) will be considered, provided the next highest bidder (s) firm is willing to pay at par the amount quoted by H 1 bidder. In this event the contract will be awarded to the Highest Bidder.

### **13. RIGHT OF ACCEPTANCE:**

- The Institute reserves all rights to reject any bids including of those bidders who fail to comply with the instructions without assigning any reason whatsoever and does not bind itself to accept the highest or any specific bids. The decision of the Institute in this regard shall be final and binding.
- Any failure on the part of the bidder to observe the prescribed procedure and any attempt to canvass for the work shall render the bidder's bids liable for rejection.
- The competent authority of the Institute reserves the right to award any or part or full contract to any successful agency (ies) at its discretion and this shall be binding on the bidders.
- In case of failure to comply with the provisions of the terms and conditions mentioned, by the agency that has been awarded the contract, the competent authority of Institute reserves the right to award the contract to the next bidder or any other outside agency.
- The Institute shall terminate the Contract if it is found that the Contractor was black listed on previous occasions by any of the Government Departments / Institutions / Local Bodies / Municipalities / Public Sector Undertaking etc. In such case, the Contractor is also liable to be blacklisted by the Institute.

### **14. RETURNING OF EARNEST MONEY DEPOSIT (BID SECURITY AMOUNT)**

- 2.1 The Earnest Money Deposit of the unsuccessful bidders shall be returned after completion of the work.
- 2.2 No interest shall be paid on Earnest Money Deposit.

### **15. CURRENCIES OF BID AND PAYMENTS**

- The Bidder shall submit his price bid / offer in Indian Rupees and payments under this contract will be made in Indian Rupees.

### **16. CONFIDENTIALITY**

- The Contractor shall take all precautions not to disclose, divulge and / or disseminate to any third party any confidential information, proprietary information on the Institute's business or security arrangements and/or business of the Institute. The obligation is not limited to any scope and the Contractor shall be held responsible in case of breach of the confidentiality of Institute's information.

### **17. GENERAL TERMS AND CONDITIONS SPECIFIC TO THE CONTRACT**

- (i) The items as per Annexure-III shall be disposed off to the bidders with the highest prices in lump sum.
- (ii) Within 07 working days of the issue of contract, the successful bidder shall be required to deposit the entire bid amount (consolidated as per Bid) to the Institute by electronic means NEFT/RTGS.
- (iii) Within 15 working days of the award of the Contract, the successful bidder shall be required to remove all the condemned items as per **Annexure-III** from the institute premises. There shall be no assistance from the Institute in this regard.
- (iv) The successful bidder shall be completely responsible for the future use / disposal of the items as per **Annexure-III** after taking the delivery.
- (v) The successful bidder shall be fully legally responsible for the disposal/condemnation of the items as per **Annexure-III** and shall comply with all laws applicable from time to time after the receipt of the condemned items from the Institute. The Institute shall have no

- role in these cases whatsoever.
- (vi) No assistance shall be provided by the office to the Contractor in executing the obligations as per the Contract and no expenses / claim of the Contractor in this regard shall be entertained, whatsoever.
  - (vii) The goods sold will be removed by the buyer(s) from the premises of NITJ within 15 working days of the award of the work order; delivery of goods shall be given only during the working hours on any working day on presenting the Release Order and authority letter by the successful bidders/purchaser(s) to the custodian of stores. During intervening period i.e. from the time of provisional acceptance of the highest Bid till physical lifting of the goods, the goods shall be lying in the NITJ premises solely at the risk and cost of the Bidder concerned. The purchaser/ successful Bidder will make his/her own arrangements for transportation and he/she will not be entitled to claim any facilities or assistance regarding transportation, loading/ unloading etc. from the Institute. In case of default, the entire amount deposited by the Bidder shall be forfeited.
  - (viii) The items are sold on 'AS IS WHERE IS BASIS' and shall be removed by the successful Bidder/Bidder fully, without any question on the part of the successful Bidder and no claim shall lie against NITJ for compensation. The successful Bidder will not be permitted to select any portion out of the goods sold to him/her nor shall any allowance be made or claim lie against NITJ for compensation on account of any mis-statement or discrepancies.
  - (ix) No price variation shall be entertained.

#### **18. CONTRACTOR'S LIABILITY**

- 18.1 The Contractor shall completely indemnify and hold harmless the Institute and its employees against any liability, claims, losses or damages sustained by it or them by reason of any breach of contract, wrongful act or negligence by the Contractor.
- 18.2 The Contractor shall not Sub-Contract, transfer or assign the contract or any other part thereof without prior written permission of the Institute. In the event of the contractor contravening this condition, the Institute shall be entitled to place the contract elsewhere on the contractors risk and cost and the contractor shall be liable for any loss or damage, which the Institute may sustain in consequence or arising out of such replacing of the contract.

**19.** Director, NITJ reserves the right to cancel this quotation without assigning any reason.

**20.** In case of any dispute, decision of the Director, NITJ will be final.

**21.** The resultant contract shall be interpreted in accordance with the laws of Union of India. Settlement of disputes shall be within the jurisdiction in Jalandhar
