- i) The bidders should have successfully carried out at least three similar works amounting to not less than 40% or two similar works amounting to not less than 50% or one similar work amounting to not less than 80% of the TENDERED cost in the last five years.
- ii) The bidders should submit the related completion certificates in support of above works issued by the respective departments.
- iii) The bidder should also have valid PAN & GST Number.

Cleaning of terrace water storage tanks including chemical treatment with Anti bacterial agent consisting of following process:-

- 1. External Washing & Dewatering: In the First Step of External Washing we wash Manhole and surroundings of outer of tank are cleaned off dirt and Dewatering of the Water Tank.
- 2. Sludge Removal: In the Second Step Sludge is removed with the help of sludge pumps.
- 3. Algae removal: In the Third Step algae, calcinations etc are removed from the walls with specially designed machine.
- 4. Internal Washing: In the Fourth Step walls and ceiling are washed through pressure jet cleaners.
- 5. Solution Treatment: In the Fifth Step walls and ceiling are sterilized with special Anti-Bacterial Solution for making it bacteria free.
- 6. Vacuum Cleaning: In the Sixth Step remaining sludge is removed with help of vacuum cleaners.
- 7. UV Treatment: In the Seventh Stage the tank is sterilized and disinfected with the help of UV Lamp to make it one time bacteria.
