- 1. The tenders should be submitted in sealed envelope. Late/delayed & tender received without EMD shall not be acceptable at all.
- 2. The Tender for Disposal of Old Logs of Uprooted/Fallen Trees are offered for disposal on "AS IS WHERE IS BASIS". Taxes and duties if any levied by Government will be extra as applicable paid by the Purchaser.
- 3. The bidder may inspect the Old Logs of Uprooted/Fallen Trees at Estate Office of the Institute up to 27./06/2017 between working days 10.00AM to 4.00PM. In this regard contact be made with Sh Anup Gupta, Estate Officer (R&M), Mobile No. 9464383867. No Complaint whatsoever will be entertained after the tender submitted or before or after the Old Logs of Uprooted/Fallen Trees are lifted. No request for inspection after submission of tender will be accepted.
- 4. The sealed tender should super scribed "TENDER FOR DISPOSAL OF OLD LOGS OF UPROOTED/FALLEN TREES" on an envelope, which will be received latest by 28.06.2017 at 3.00 PM through Indian post or by hand in the Dispatch Section of the Institute. The same will be opened on 28 .06.2017 at 3.30 PM in the presence of bidders, if any. No tenders either by post or in hand will be received after the schedule date and time as specified above. - 5. The offers given in the valid tenders received on due date and time and accompanied by the required amount of Earnest Money will be considered failing which, tender received treated as invalid.
- 6. The tender form must accompany the earnest money amounting to Rs. 10,000/- for old logs of uprooted/fallen trees by demand draft in favour of Director, NIT Jalandhar. The tender form submitted without earnest money will not be considered. The earnest money of the unsuccessful bidder will be returned after finalization of the award to successful bidder.
- 7. In the event of acceptance of tender, the successful bidder be required to deposit full amount of offer, in shape of DD in favour of DIRECTOR, NIT Jalandhar within 3 (three) days from the issue of sale order, failing which the sale order shall be cancelled and EMD will be forfeited automatically.
- 8. The old logs of uprooted/fallen trees will be delivered only after the receipt of full payment and has to be lifted within 04 days of completion of deal failing which, ground rent at the rate of Rs.500/- day will be

charged. Permission to take out the disposed old logs of uprooted/fallen trees from Institute will not be allowed on holidays, Saturdays and Sundays etc.

- 9. The person authorized by bidder will be allowed to take the delivery. The bidders are required to attach any of documents as documentary evidence for proof of their address. Therefore, the bidders shall be required to submit documentary evidence in support of residential status (Ration Card/Voters Identity Card/Adhar Card/PAN Card in case of individual and Registration Certificate in case of firms etc.) along with duly filled in prescribed tender form.
- 10. The address given in the tender shall be deemed to be bidders address and correspondence sent on that address shall be considered to have been delivered to the bidder. No claim will be entertained for the reason of forfeiture of the sum deposited in case the correspondence is received back undelivered.
- 11. Once the release sale order issued, this office will not be responsible either for safe custody or for any loss or damage to the subject old logs of uprooted/fallen trees. The highest bid once accepted is not transferable to anyone. In case the bidder is a company, the name of the company should be indicated as the bidder. In such cases the person appearing for the company should have the authorization letter in a proper format issued from a competent authority of the company. Request to change the name of the bidder in the tender after submission of the tender will not be entertained.
- 12. The scheduled day for submission/opening the sealed tenders, if declared to be holiday due to any reason unforeseen arise, the same will be submitted/opened the next immediate working day at schedule time already mentioned.
- 13. The bidders should quote the amount for purchase of the subject old logs of uprooted/fallen trees both in words and in figures, if there is any difference between the amounts given in figures and that of in words, the rate quoted in words alone will be taken in to account and accepted on record. The minimum reserve price as fixed by the NIT Jalandhar will be the benchmark for the sale of the old logs of uprooted/fallen trees. Only the highest bid amount (for all old logs of uprooted/fallen trees) in and above the minimum reserve price will be accepted.
- 14. The bidders will not be allowed to withdraw their bids, failing which Earnest Money will be forfeited.
- 15. Award for Sale for old logs of uprooted/fallen trees:- The award of sale for old logs of uprooted/fallen trees will be placed to the tenderer whom rates found highest amongst offers received this tender on the basis of total quoted rates of all the types of wooden logs. However, the sale of for old logs of uprooted/fallen trees will be made on actual measurement basis in the presence of committee duly constituted by the Director of the Institute and tenderer.
- 16. If highest bidder does not accept the offer of sale of old logs of uprooted/fallen trees for any reason whatsoever it may be, and withdraws from the bidding, the EMD deposited by such bidder will be forfeited. The second highest bid amount may be considered for sale, if accepted by DIRECTOR, NIT Jalandhar and accordingly the second highest bid amount will be considered as the highest bid amount, subject to minimum reserve price conditions. If such second highest bidder also does not prefer the sale offer and withdraws from the bidding, after having decided as the highest bidder, the EMD deposited by

him/her will also be forfeited to the NIT Jalandhar and the proceeding initiated in this notice will be considered as final and unsuccessful.

- 17. No man power will be provided by the Institute for lifting the disposal old logs of uprooted/fallen trees.
- 18. If there will be any tax raised by Forest Department/ other Agency, the same will be paid by successful bidder. Beside this, any other permission required to lift the material same will be obtained by the bidder.
- 19. NIT Jalandhar will not be responsible for any loss suffered by the bidder or his men for whatsoever reason. NIT Jalandhar will not be responsible for any loss of damage during lifting and transit the old logs of uprooted/fallen trees from the Institute.
- 20. All workers engaged by the successful bidders including himself/herself should strictly follow all the safety and security norms during lifting and transit the old logs of uprooted/fallen trees from the Institute. The labourers engaged by successful bidder should strictly follow the discipline and decorum of the Institute and he will be liable for any loss or damage caused by them to the Institute property. The Institute will not be held responsible for payment of any compensation to the labourer engaged by him for any sort of things in case of accident.
- 21. The Director, NIT Jalandhar reserves the right to reject any or all the tenders without assigning any reasons. The Director, NIT Jalandhar also reserves the right to withdraw the sale of said old logs of uprooted/fallen trees fully or partly to the successful tenderers without assigning any reasons thereof. The decision of the Director NIT Jalandhar will be final in this regard during the process of this tender & sale at any stage.
- 22. If there is any dispute/doubt, the decision of the Director, Dr. B. R. Ambedkar National Institute of Technology, Jalandhar shall be final. All disputes are subject to Jalandhar Jurisdiction.
